8 **A Resolution authorizing the County Executive to execute any documents necessary to**
9 **accept the award from the Ohio Department of Public Safety's Office of Criminal Justice**
10 **Services of an Edward Byrne Memorial Justice Assistance Grant, for the period 1/1/20**
11 **through 12/31/20, in the amount of \$89,999.63, with a 25% local cash match requirement of**
12 **\$29,999.88, for a total amount of \$119,999.51, for the Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services
15 ("ODPS-OCJS") has awarded the Summit County Sheriff's Office an Edward Byrne Memorial
16 Justice Assistance Grant, for the period 1/1/20 through 12/31/20, in the amount of \$89,999.63,
17 with a 25% local cash match requirement of \$29,999.88, for a total amount of \$119,999.51; and

19 WHEREAS, this Edward Byrne Memorial Justice Assistance grant will fund a
20 countywide drug unit task force which will specifically target the manufacture, distribution and
21 acquisition of illegal drugs in Summit County; and

23 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit
24 County Drug Unit checking account; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the County
28 Executive to execute any documents necessary to accept the award of the aforementioned
29 Edward Byrne Memorial Justice grant from the ODPS-OCJS;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award by the Ohio Department of Public Safety's Office of Criminal Justice Services
38 ("ODPS-OCJS") of an Edward Byrne Memorial Justice Assistance grant, for the period 1/1/20
39 through 12/31/20, in the amount of \$89,999.63, with a 25% local cash match requirement of
40 \$29,999.88, for a total amount of \$119,999.51.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit and for the further reason to immediately
46 authorize the Executive to execute any documents necessary to accept the award of the Edward
47 Byrne Memorial Justice Assistance Grant from ODPS-OCJS, so that the same may be used to
48 fund the Sheriff's drug unit task force operations as soon as possible.



8 effect and be in force at the earliest time provided by law.




