7 **A Resolution confirming the award by the Board of Control of a professional service**  
8 **contract with Oriana House, Inc., as a Best Practical Source, for two full-time case**  
9 **managers and one full-time recovery support specialist, to provide support and treatment**  
10 **services to Valor Court participants, for a one-year term, from 9/30/19 through 9/29/20, in**  
11 **an amount not to exceed \$210,332.00, for the Court of Common Pleas-General Division,**  
12 **Adult Probation, and declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2019-359, which  
15 authorized the County Executive to execute any documents necessary to accept a Fiscal Year  
16 2019 Treatment Drug Courts grant from the United States Department of Health and Human  
17 Services, Substance Abuse and Mental Health Services Administration ("SAMSHA") for the  
18 Valor Court Expansion and Enhancement Project, in the amount \$354,321.00, with no local cash  
19 match requirement, for the period 9/30/19 through 9/29/20; and

21 WHEREAS, the Court of Common Pleas-General Division, Adult Probation, wishes to  
22 enter into a professional service contract with Oriana House, Inc., as a Best Practical Source, for  
23 two full-time case managers and one full-time recovery support specialist, to provide support and  
24 treatment services to Valor Court participants, for a one-year term, from 9/30/19 through  
25 9/29/20, to be funded by the SAMSHA grant; and

27 WHEREAS, the Board of Control, at its meeting held March 25, 2020, awarded a  
28 professional service contract with Oriana House, Inc., as a Best Practical Source, for two full-  
29 time case managers and one full-time recovery support specialist, to provide support and  
30 treatment services to Valor Court participants, for a one-year term, from 9/30/19 through  
31 9/29/20, in an amount not to exceed \$210,332.00; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
34 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in  
35 the best interest of the County of Summit;

42 The award by the Board of Control of a professional service contract with Oriana House,  
43 Inc., as a Best Practical Source, for two full-time case managers and one full-time recovery  
44 support specialist, to provide support and treatment services to Valor Court participants, for a  
45 one-year term, from 9/30/19 through 9/29/20, in an amount not to exceed \$210,332.00, is hereby  
46 confirmed and the County Executive is hereby authorized to execute such professional service  
47 contract and any other necessary related documents.
