7 **A Resolution, pursuant to Sections 177.13 and 177.07 of the Codified Ordinances of the**  
8 **County of Summit, authorizing purchases by the County Executive from Applied**  
9 **Specialties, Inc., at the same pricing as another Ohio political subdivision, of sodium**  
10 **aluminate for use at Waste Water Treatment Plant No. 36, Upper Tuscarawas, in**  
11 **Springfield Township, Council District 8, in calendar year 2020, in a total aggregate**  
12 **amount not to exceed \$65,835.00, for the Executive’s Department of Sanitary Sewer**  
13 **Services, and declaring an emergency.**

14  
15 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit  
16 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar  
17 year, where no additional competitive quotes or bids have been taken, shall be made only upon  
18 authorization of County Council; and

20 WHEREAS, sodium aluminate is used to remove phosphorus from the influent waste  
21 water at Waste Water Treatment Plant No. 36, Upper Tuscarawas (“WWTP No. 36”), in  
22 Springfield Township, in Council District 8; and

24 WHEREAS, the City of Defiance, Ohio awarded an open bid contract for the same  
25 pricing; and

26  
27 WHEREAS, pursuant to Section 177.07(a)(10) of the Codified Ordinances of the County  
28 of Summit, the County Executive anticipates making purchases of sodium aluminate from  
29 Applied Specialties, Inc., at the same pricing as another Ohio political subdivision, in calendar  
30 year 2020, and requests authorization to make said purchases in an estimated amount of 315,000  
31 lbs. for use at WWTP No. 36, for a total aggregate amount not to exceed \$65,835.00; and

33 WHEREAS this Council finds and determines, after reviewing all pertinent information,  
34 that it is necessary and in the best interest of the County to authorize purchases by the County  
35 Executive of sodium aluminate from Applied Specialties, Inc., at the same pricing as another  
36 Ohio political subdivision, for use at WWTP No. 36 in calendar year 2020, in a total aggregate  
37 amount not to exceed \$65,835.00;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
40 of Ohio, that:

44 Pursuant to Sections 177.13 and 177.07 of the Codified Ordinances of the County of  
45 Summit, this Council hereby authorizes purchases by the County Executive from Applied  
46 Specialties, Inc., at the same pricing as another Ohio political subdivision, of sodium aluminate  
47 for use at Waste Water Treatment Plant No. 36, Upper Tuscarawas (“WWTP No. 36”), in  
48 Springfield Township, in Council District 8, in calendar year 2020, in a total aggregate amount  
49 not to exceed \$65,835.00.

14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
