WHEREAS, County Council subsequently adopted Resolution No. 2019-321, which approved the assignment of the professional service contract between the County and The Centers for Families and Children d.b.a. Ease@Work for EAP services to AllOne Health Resources Inc., including the two renewals of said contract approved by Resolution No. 2018-321; and

WHEREAS, the Board of Control, at its meeting held March 25, 2020, awarded a renewal (first of two) of a professional service contract with AllOne Health Resources, Inc. (Ease@Work) for EAP services for County employees and employees of other participating political subdivisions, for a one-year term, from 1/1/20 through 12/31/20, for an amount not to exceed \$18.30 per employee per year, for a total amount not to exceed \$123,452.00, subject to confirmation by County Council; and
