7 **A Resolution authorizing the County Executive to advertise for bids for the Summit**
8 **County Jail Storage Building Project, for an estimated total cost not to exceed \$85,000.00,**
9 **for the Executive's Department of Administrative Services – Physical Plants, and declaring**
10 **an emergency.**

12 WHEREAS, the Maintenance Department at the Summit County Jail currently has no
13 facility to store their maintenance equipment and materials out of the weather; and

14
15 WHEREAS, the County Executive recommends that a 1,200 square foot storage building
16 be constructed for the purpose of storing and protecting, from the weather, said maintenance
17 equipment and materials; and

18
19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
20 requires this Council's authorization for the County Executive to advertise for bids; and

21
22 WHEREAS, the County Executive wishes to advertise for bids for the aforementioned
23 Summit County Jail Storage Building Project, in Council District 4, for an estimated total cost
24 not to exceed \$85,000.00; and

26 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 advertise for bids for the Summit County Jail Storage Building Project, in Council District 4, for
32 an estimated total cost not to exceed \$85,000.00;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

39 The County Executive is authorized to advertise for bids for the Summit County Jail
40 Storage Building Project, in Council District 4, for an estimated total cost not to exceed
41 \$85,000.00.

45 This Resolution is declared an emergency in the interest of the health, safety, and welfare
46 of the residents of the County of Summit, and for the further reason that it immediately
47 authorizes the advertisement for bids for a necessary storage building for maintenance equipment
48 and materials at the Summit County Jail.
