7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Sadler-NeCamp Financial Services, Inc. dba Proware, as a Sole Source, for**
9 **an e-filing module to be added to and integrated with its case management system,**
10 **including software licenses and support services through 12/31/20, for an amount not to**
11 **exceed \$82,950.00, for the Court of Common Pleas-Juvenile Division, and declaring an**
12 **emergency.**

14 WHEREAS, the Supreme Court of Ohio has awarded the County of Summit Court of
15 Common Pleas-Juvenile Division a technology grant to upgrade its current case management
16 system to allow for e-filing, which will provide attorneys, pro se litigants and Summit County
17 Children Services online access to file documents, applications for sealings and expungement of
18 records and new cases with the Court of Common Pleas-Juvenile Division; and

20 WHEREAS, the entire cost of the upgrade will be covered by a Supreme Court
21 Technology Grant which was appropriated in Resolution 2020-039; and

23 WHEREAS, the Juvenile Division's current case management system is run by the
24 proprietary software of Sadler-NeCamp Financial Services, Inc. dba Proware; and

26 WHEREAS, the Board of Control, at its meeting held February 19, 2020, awarded a
27 professional service contract with Sadler-NeCamp Financial Services, Inc. dba Proware, as a
28 Sole Source, approved by the IT Board on 2/13/20, for an e-filing module to be added to and
29 integrated with its case management system, including software licenses and support services
30 through 12/31/20, for an amount not to exceed \$82,950.00, subject to confirmation by County
31 Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that the aforementioned professional service contract with Sadler-NeCamp Financial Services,
35 Inc. dba Proware is necessary and in the best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

46 \$82,950.00, is hereby confirmed and the County Executive is hereby authorized to execute such
47 professional service contract and any other necessary related documents.
