7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Language Line Services, Inc. for over-the-phone**
9 **interpreter services for non-English speaking clients, for the period of 3/1/18 to 2/28/21, in**
10 **an amount not to exceed \$215,000.00, (a cumulative increase of 53.09%), for a total amount**
11 **not to exceed \$620,000.00, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2018-076, which
15 confirmed the award by the Board of Control of a professional service contract with Language
16 Line Services, Inc., for over-the-phone interpreter services for non-English speaking clients, for
17 the period of 3/1/18 to 2/28/21, at State Term Pricing, in an amount not to exceed \$405,000.00;

20 WHEREAS, a change order is necessary to increase the agreement compensation amount
21 to meet growing client demand for the aforementioned services; and

23 WHEREAS, the Board of Control, at its February 5, 2020 meeting, awarded Change
24 Order No. 1 to the professional service contract with Language Line Services, Inc. for over-the-
25 phone interpreter services for non-English speaking clients, for the period of 3/1/18 to 2/28/21, in
26 an amount not to exceed \$215,000.00, (a cumulative increase of 53.09%), for a total amount not
27 to exceed \$620,000.00; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned Change Order No. 1 to the professional service contract with Language
31 Line Services, Inc. is necessary and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

41 total amount not to exceed \$620,000.00, is hereby confirmed and the County Executive is hereby
42 authorized to execute such change order and any other necessary related documents.
