7 **A Resolution authorizing the County Executive to advertise for bids for the Canton Road**
8 **Resurfacing Project for a total estimated cost not to exceed \$465,727.57 and authorizing the**
9 **Executive to execute an agreement, for said Project, with the lowest responsive and**
10 **responsible bidder, upon approval from the Board of Control, located in Springfield**
11 **Township, Council District 8, for the Engineer and declaring an emergency.**

12
13 WHEREAS, the County Engineer has determined there is a public need to resurface
14 Canton Road from Salmon Drive to 500 feet south of Springfield Lake Drive in Springfield
15 Township, in Council District 8 (the "Project"); and

16
17 WHEREAS, the Akron Metropolitan Area Transportation Study ("AMATS") has
18 awarded to the County federal Surface Transportation Block Grant funds, which will cover 80%
19 of the construction costs of the Project; and

20
21 WHEREAS, the Ohio Department of Transportation has stipulated the Project must be
22 put out to bid March 2, 2020 and awarded by March 30, 2020, in order to receive the funds; and

23
24 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
25 requires this Council's authorization to advertise for bids for said improvements; and

26
27 WHEREAS, in addition to authorizing the advertisement of the Project, this Council
28 further authorizes the Executive to execute an agreement, for said Project, with the lowest
29 responsive and responsible bidder, upon approval from the Board of Control, so long as such bid
30 does not exceed 10% of the Engineer's estimate for said Project ; and

32 WHEREAS, the total estimated cost of the Project is \$465,727.57; and

33
34 WHEREAS, this Council has determined by reviewing all pertinent information that it is
35 necessary and in the best interest of the County of Summit that the County Executive be
36 authorized to advertise for bids as necessary for the Project and execute an agreement, for said
37 Project, with the lowest responsive and responsible bidder, upon approval from the Board of
38 Control, for a total estimated cost not to exceed \$465,727.57, so long as such bid does not exceed
39 10% of the Engineer's estimate for said Project;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that;

46 The County Executive is authorized to advertise for bids for the Canton Road
47 Resurfacing Project, located in Springfield Township, Council District 8, for an estimate cost not
48 to exceed \$465,727.57 and is further authorized to execute an agreement, for said Project, with
49 the lowest responsive and responsible bidder, upon approval from the Board of Control, so long
50 as such bid does not exceed 10% of the Engineer's estimate for said Project.


