8 **totaling \$61,303.41 in order to meet projected expenditures for the balance of 2020 as set**
9 **forth in Exhibit A, for the Executive's Department of Finance and Budget, and declaring**
10 **an emergency.**

12 WHEREAS, certain operations of the County of Summit require appropriations in the
13 amount of \$999,653.28 in order to meet obligations for the balance of the 2020 calendar year as
14 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated; and

16 WHEREAS, certain operations of the County of Summit additionally require
17 appropriation adjustments in the amount of \$61,303.41 in order to meet obligations for the
18 balance of the 2020 calendar year as set forth in Exhibit A, attached to this Resolution and
19 incorporated herein as if fully restated; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that the
22 appropriations contained in Exhibit A are immediately needed for operations of the County and
23 are necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The County Fiscal Officer is hereby authorized and directed to effect the appropriations
31 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated and
32 establish funds 27439, 27440, 27450, 27460, 27470 and 27480.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the residents of the County of Summit and for the further reason that the
38 appropriations contained in Exhibit A are immediately needed for operations of the County.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,

52 121.22 of the Ohio Revised Code.
