7 **A Resolution confirming the award by the Board of Control of a renewal (second and final)**
8 **of a professional service contract with Quality Control Inspection, Inc., as a Best Practical**
9 **Source, for construction inspection services for a one-year term, from 1/1/20 through**
10 **12/31/20, in an amount not to exceed \$90,000.00, for the Engineer, and declaring an**
11 **emergency.**

13 WHEREAS, the County Engineer's Office has five full time construction inspectors on
14 staff, who inspect and manage approximately 50 annual projects worth between \$5,000,000.00
15 and \$8,000,000.00; and

16
17 WHEREAS, at certain times, the Engineer's staff inspectors cannot sufficiently inspect
18 and manage all of the construction projects in progress, which necessitates hiring private
19 inspectors in order to ensure that a construction inspector is on site at all times to ensure that all
20 construction projects are built to plans, specifications, and contract requirements; and

22 WHEREAS, County Council previously adopted Resolution No. 2017-361, which
23 confirmed the award by the Board of Control of a professional service contract with Quality
24 Control Inspection, Inc., as a Best Practical Source, for construction inspection services for a
25 one-year term, with two options to renew for an additional one-year term, in an amount not to
26 exceed \$90,000.00; and

28 WHEREAS, the Board of Control, at its January 8, 2020 meeting, awarded a renewal
29 (second and final) of a professional service contract with Quality Control Inspection, Inc., as a
30 Best Practical Source, for construction inspection services, for a one-year term, from 1/1/20
31 through 12/31/20, in an amount not to exceed \$90,000.00; and

33 WHEREAS, this Council finds and determines after reviewing all pertinent information,
34 that the aforementioned renewal (second and final) of a professional service contract with
35 Quality Control Inspection, Inc. is necessary and in the best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The award by the Board of Control of a renewal (second and final) of a professional
43 service contract with Quality Control Inspection, Inc., as Best Practical Source, for construction
44 inspection services for a one-year term, from 1/1/20 through 12/31/20, in an amount not to
45 exceed \$90,000.00, is hereby confirmed and the County Executive is hereby authorized to
46 execute said professionals service contract and any necessary related documents.
