A Resolution confirming an award by the Board of Control of a purchase contract with Ports Petroleum Company, Inc. for unleaded and diesel fuel for general fleet operations, at State Term pricing, in an amount not to exceed \$200,000.00, for the Engineer, and declaring an emergency.

## SECTION 1

The award by the Board of Control of a purchase contract with Ports Petroleum Company, Inc., at State Term Pricing, for unleaded and diesel fuel for general fleet operations, at State Term pricing, in an amount not to exceed \$200,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such purchase contract and any other necessary related documents.
