7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the Ohio Department of Public Safety's Office of Criminal Justice**
9 **Services of an Edward Byrne Memorial Justice Assistance grant, for the period 1/1/15**
10 **through 12/31/15, in the amount of \$39,998.01, with a 25% local cash match requirement of**
11 **\$13,332.68, and appropriating funds in the amount of \$53,330.69, for Fiscal Year 2015, for**
12 **the Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services
15 ("ODPS-OCJS") has awarded the County Sheriff's Office an Edward Byrne Memorial Justice
16 Assistance grant, for the period 1/1/15 through 12/31/15, in the amount of \$39,998.01 with a
17 25% local cash match requirement of \$13,332.68; and

19 WHEREAS, this Edward Byrne Memorial Justice Assistance grant will fund a
20 countywide drug unit task force which will specifically target the manufacture, distribution and
21 acquisition of illegal drugs in Summit County; and

23 WHEREAS, the local cash match will be provided by funds from the Sheriff's Summit
24 County Drug Unit checking account; and

26 WHEREAS, it is necessary to appropriate funds in the amount of \$53,330.69; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Executive to execute any documents necessary to accept the award of the aforementioned
31 Edward Byrne Memorial Justice grant from the ODPS-OCJS, and to appropriate grant funds and
32 the local cash match;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

40 the award by the Ohio Department of Public Safety's Office of Criminal Justice Services

42 through 12/31/15, in the amount of \$39,998.01, with a 25% local cash match requirement of
43 \$13,332.68.




