7 **A Resolution authorizing the County Executive to execute a three-year policing contract**  
8 **with the Akron-Canton Regional Airport Authority Board, in Council District 8, pursuant**  
9 **to which the County Sheriff will provide the Regional Airport with 19,820.98 Sheriff's**  
10 **Deputy/Sergeant hours, for the period 1/1/15 through 12/31/17, with two options to renew**  
11 **for an additional three-year term, in exchange for payment by the Regional Airport of a**  
12 **total gross amount of \$3,674,376.20, less a contingent credit, during the three-year term of**  
13 **the contract, for the Sheriff, and declaring an emergency.**

14  
15 WHEREAS, County Council previously adopted Resolution No. 2011-521, which  
16 authorized the County Executive to execute a three-year policing contract with Akron-Canton  
17 Regional Airport Authority Board (the "Regional Airport"), in Council District 8, which expired  
18 on 12/31/14; and

19  
20 WHEREAS, the Regional Airport has requested that the County of Summit enter into a  
21 new contract pursuant to which the County Sheriff will provide 19,820.98 deputy/sergeant hours,  
22 for the period 1/1/15 through 12/31/17, with two options for renew for an additional three-year  
23 term; and

25 WHEREAS, the new contract, which is attached to this Resolution as Exhibit A, provides  
26 that the Regional Airport will pay the County a gross amount of \$1,194,762.14 for the first year,  
27 a gross amount of \$1,225,079.36 for the second year and a gross amount of \$1,254,534.71 for the  
28 third year, for a total gross amount of \$3,674,376.20 during the three-year term of the contract;

31 WHEREAS, the County has agreed to provide a "smoothing credit" of \$482,000.00 over  
32 the three-year term of the contract, whereby the Regional Airport has agreed to pay the County  
33 \$994,761.14 for the first year, \$1,063,078.35 for the second year and \$1,134,533.71 for the third  
34 year, for a total amount of \$3,192,373.20 during the three-year term of the contract; and

36 WHEREAS, the smoothing credit of \$482,000.00 is contingent upon the Regional  
37 Airport renewing the contract for an additional three-year term, at which time the credit will be  
38 repaid during the renewal term; and

39  
40 WHEREAS, should the Regional Airport not renew the contract, it will be obligated to  
41 immediately repay the County a lump sum of \$482,000.00; and

43 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
44 that it is necessary and in the best interest of the County of Summit to authorize the County  
45 Executive to execute for aforementioned policing contract with the Regional Airport;

47 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

4 SECTION 1

5  
6 The County Executive is hereby authorized to execute a three-year policing contract with  
7 the Akron-Canton Regional Airport Authority Board (the "Regional Airport"), in Council  
8 District 8, pursuant to which the County Sheriff will provide the Akron-Canton Airport with  
9 19,820.98 deputy/sergeant hours, for the period of 1/1/15 through 12/31/17, in exchange for  
10 payment by Regional Airport of a total gross amount of \$3,674,376.20, less a contingent credit,  
11 during the three-year term of the contract. A copy of the contract is attached hereto as Exhibit A  
12 and the County Executive is authorized to execute the same in substantially the same version as  
13 attached, provided that any changes to the same are not materially adverse to the County.

15 SECTION 2

16  
17 This Resolution is hereby declared an emergency in the interest of the health, safety and  
18 welfare of the citizens of the County of Summit and for the further purpose of immediately  
19 providing necessary policing for the Regional Airport, in Council District 8, effective 1/1/15.

21 SECTION 3

22  
23 Provided this Resolution receives the affirmative vote of eight members, it shall take  
24 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
25 effect and be in force at the earliest time provided by law.

27 SECTION 4

29 It is found and determined that all formal actions of this Council concerning and relating  
30 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
31 deliberations of this Council and of any of its committees that resulted in such formal action,  
32 were in meetings open to the public, in compliance with all legal requirements, including Section  
33 121.22 of the Ohio Revised Code.
