7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award of a grant of federal funds from the Ohio Department of Youth Services,**
9 **for the period 10/1/14 through 9/30/15, in the amount of \$9,693.00, with no local cash match**
10 **requirement, appropriating said grant funds and appropriating RECLAIM Ohio funds, in**
11 **the amount of \$5,000.00, to supplement said grant funds, for a total appropriation in the**
12 **amount of \$14,693.00 for expenditures through 12/31/15, for the Court of Common Pleas -**
13 **Juvenile Division, and declaring an emergency.**

14
15 WHEREAS, the Ohio Department of Youth Services (“ODYS”) has awarded the Court
16 of Common Pleas - Juvenile Division a grant of federal funds in the amount of \$9,693.00, with
17 no local cash match requirement, for the period 10/1/14 through 9/30/15; and

18
19 WHEREAS, said grant funds will provide 25% of the salary cost for probation officer
20 Ken Jones; and

22 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State’s
23 overburdened juvenile justice system and allows local courts to target specific areas to help
24 divert youth from being institutionalized; and

25
26 WHEREAS, there are \$5,000.00 in RECLAIM Ohio funds available as a supplement to
27 pay benefits associated with the 25% salary cost funded by the ODYS grant; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 execute any documents necessary to accept the award of the aforementioned grant from the
32 ODYS, to appropriate said grant funds and to appropriate said RECLAIM Ohio funds;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive is hereby authorized to execute any documents necessary to accept
