7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award of a Fiscal Year 2013 Urban Search and Rescue Grant from the Ohio**  
9 **Emergency Management Agency, for the period 9/1/13 through 6/30/15, in the amount of**  
10 **\$33,000.00, with no local cash match requirement, and appropriating these grant funds, for**  
11 **the Executive's Department of Law, Insurance and Risk Management – Division of Public**  
12 **Safety/Emergency Management Agency, and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency ("OEMA") has awarded a Fiscal  
15 Year 2013 Urban Search and Rescue Grant to the Summit County Emergency Management  
16 Agency ("SCEMA"), for the period 9/1/13 through 6/30/15, in the amount of \$33,000.00, with  
17 no local cash match requirement; and

19 WHEREAS, the purpose of the grant is to help sustain the urban area search and rescue  
20 capabilities through the purchase of equipment, expendable materials and supplies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the County  
24 Executive to execute any documents necessary to accept the award of the aforementioned grant  
25 and to appropriate these grant funds;
