12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for one polymerase chain
16 reaction biological identification system, for an estimated total cost not to exceed \$56,350.00;

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for one polymerase chain reaction biological identification system, for an
24 estimated total cost not to exceed \$56,350.00;

31 The County Executive is authorized to advertise for bids for one polymerase chain
32 reaction biological identification system, for an estimated total cost not to exceed \$56,350.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare
37 of the citizens of the County of Summit, and for the further reason that it authorizes the
38 Executive to immediately advertise for bids for one polymerase chain reaction biological
39 identification system, the purchase of which will be through homeland security grant funding
40 which expires 5/31/15.
