7 **A Resolution appropriating funds from the County of Summit Alcohol, Drug Addiction**
8 **and Mental Health Services Board, for the Psycho-Diagnostic Clinic, for the period 1/1/15**
9 **through 12/31/15, in the amount of \$432,608.68, with no local cash match requirement, for**
10 **the Court of Common Pleas – General Division, and declaring an emergency.**

12 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services
13 Board (“ADM”) has certified that pass-through grant funds are available, primarily from the
14 State of Ohio Department of Mental Health, in the amount of \$395,237.00, with no local cash
15 match requirement, for the period 1/1/15 through 12/31/15; and

16
17 WHEREAS, additional court revenues in the amount of \$12,000.00, with no local cash
18 match requirement, are available along with the aforementioned 2015 award; and

19
20 WHEREAS, the Court of Common Pleas –General Division has various carryover funds
21 totaling \$25,371.68; and

23 WHEREAS, the Psycho-Diagnostic Clinic is needed to provide court-ordered evaluations
24 in criminal cases, and the aforementioned monies will be used to reimburse the Clinic for
25 expenditures; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to appropriate the
29 aforementioned grant funds in the total amount of \$432,608.68, with no local cash match
30 requirement;

27 Section 121.22 of the Ohio Revised Code.


