7 **A Resolution authorizing the County Executive to advertise for bids as needed for roadway**  
8 **engineering and construction projects, bridge engineering and construction projects,**  
9 **pavement maintenance projects and vehicles, for the County Engineer's 2015 Capital**  
10 **Improvement Program and federal and state funded projects, for an estimated total cost**  
11 **not to exceed \$8,996,619.00, for the Engineer, and declaring an emergency.**

13 WHEREAS, the County of Summit's 2015 Capital Improvement Program, which  
14 included highway and bridge improvements for the Engineer, has been submitted to this Council;  
15 and

16  
17 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
18 requires this Council's authorization to advertise for bids; and

19  
20 WHEREAS, in addition to authorizing the advertisement of projects, this Council will  
21 also award the contracts for each of the projects; and

22  
23 WHEREAS, the total estimated cost of the aforementioned projects is \$8,996,619.00; and

24  
25 WHEREAS, the County Executive wishes to advertise for bids as needed for roadway  
26 engineering and construction projects, bridge engineering and construction projects, pavement  
27 maintenance projects and vehicles, for the County Engineer's 2015 Capital Improvement  
28 Program and federal and state funded projects; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
32 advertise for bids as needed for roadway engineering and construction projects, bridge  
33 engineering and construction projects, pavement maintenance projects and vehicles, for the  
34 County Engineer's 2015 Capital Improvement Program and federal and state funded projects, for  
35 an estimated total cost not to exceed, \$8,996,619.00, subject to the appropriation of funds;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that;

42 The County Executive is authorized to advertise for bids for the following categories of  
43 infrastructure improvements for the estimated total not to exceed amounts stated:

45 2015 Vehicles/Equipment \$ 576,000.00  
46 2015 Bridge Engineering and Construction \$ 210,000.00  
47 2015 Pavement, Culvert, and Ditch Maintenance \$ 5,735,000.00  
48 2015 Roadway Engineering and Construction \$ 450,000.00  
49 Ravenna Rd Bridge over Tinkers Creek \$ 1,540,000.00  
50 Van Buren Rd. Bridge Microsilica Overlay \$ 360,000.00  
51 Facilities \$ 125,619.00
