7 **A Resolution authorizing the County Executive to advertise for bids for a purchase**
8 **contract or lease of personal property, for the Summit County Parking Deck Equipment**
9 **Replacement Project, for an estimated cost not to exceed \$295,000.00, for the Executive's**
10 **Department of Administrative Services – Division of Physical Plants, and declaring an**
11 **emergency.**

13 WHEREAS, Section 177.05 and 177.10 of the Codified Ordinances of the County of
14 Summit require this Council's authorization for the County Executive to advertise for bids for
15 the purchase or lease of personal property in excess of \$25,000.00; and

16
17 WHEREAS, the County Executive wishes to advertise for bids for the Summit County
18 Parking Deck Equipment Replacement Project for the purchase or lease of new equipment for
19 the parking deck for an estimated amount not to exceed \$295,000.00; and

21 WHEREAS, the current equipment in the parking deck is outdated, breaks often, and
22 lacks the technology found in modern parking deck equipment; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County to authorize the Executive to advertise
26 for bids for a purchase contract or lease of personal property for the Summit County Parking
27 Deck Equipment Replacement Project, as set forth above.

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

32 SECTION 1

34 The County Executive is authorized to advertise for bids for a purchase contract or lease
35 of personal property, for the Summit County Parking Deck Equipment Replacement Project, for
36 an estimated cost not to exceed \$295,000.00. A copy of the plans and specifications are on file in
37 the Clerk of Council's office.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of the County of Summit and for the further reason that it allows the
43 County Executive to immediately advertise for bids and proceed with the aforementioned project
44 in order to eliminate/reduce equipment breakdowns and inconvenience to the users of the
45 parking deck.

49 Provided this Resolution received the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
