7 **A Resolution appropriating funds from the County of Summit Alcohol, Drug Addiction**
8 **and Mental Health Services Board, for a Behavioral Health Service grant, for the period**
9 **1/1/15 through 12/31/15, in the amount of \$245,346.00, with no local cash match**
10 **requirement, for the Court of Common Pleas – Juvenile Division, and declaring an**
11 **emergency.**

13 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services
14 Board (“ADM”) has certified that pass-through grant funds are available, primarily from the
15 State of Ohio Department of Mental Health, for the period 1/1/15 through 12/31/15, in the
16 amount of \$245,346.00, with no local cash match requirement; and

18 WHEREAS, a Behavioral Health Service grant is needed to fund four hours per month of
19 psychiatric support to youth in detention; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to appropriate the
23 aforementioned grant funds in the total amount of \$245,346.00, with no local cash match
24 requirement;


