7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Language Line Services, Inc., for over-the-phone interpreter services for**
9 **non-English speaking clients, for the period 3/1/15 through 2/29/16, under State Term**
10 **Pricing, in an amount not to exceed \$140,000.00, for the Executive's Department of Job and**
11 **Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held January 14, 2015, awarded a
14 professional service contract with Language Line Services, Inc., for over-the-phone interpreter
15 services for non-English speaking clients, for the period 3/1/15 through 2/29/16, under State
16 Term Pricing, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with Language Line
27 Services, Inc., for over-the-phone interpreter services for non-English speaking clients, for the
28 period 3/1/15 through 2/29/16, under State Term Pricing, in an amount not to exceed
29 \$140,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
30 contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for interpreter services effective 3/1/15.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,


