7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Cargill, Inc., for road salt for snow and ice control, under CUE pricing, in an amount not**

11 WHEREAS, the Board of Control, at its meeting held January 28, 2015, awarded a
12 purchase order with Cargill, Inc., for road salt for snow and ice control, under CUE pricing,
13 subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a purchase order with Cargill, Inc., for road salt for
24 snow and ice control, under CUE pricing, in an amount not to exceed \$725,000.00, is hereby
25 confirmed and the County Executive is hereby authorized to execute such purchase order.

29 This Resolution is hereby declared an emergency in the interest of the health, safety and
30 welfare of the citizens of the County of Summit, and for the further reason to immediately
31 provide road salt for snow and ice control in 2015.

35 Provided this Resolution receives the affirmative vote of eight members, it shall take
36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
37 effect and be in force at the earliest time provided by law.

42 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
43 deliberations of this Council and of any of its committees that resulted in such formal action,

45 121.22 of the Ohio Revised Code.
