7 **A Resolution appropriating funds for Change Order No. 2 to a construction contract with**  
8 **Guinto Schirak for the Ravenna Road Bridge over Tinker's Creek Improvement Project,**  
9 **in Council District 1, in an amount not to exceed \$24,971.98 (3.89% increase), including a**  
10 **local match of \$4,994.40, for the period ending 12/31/15, for the Engineer, and declaring an**  
11 **emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2014-184, which  
14 confirmed an award by the Board of Control of a construction contract for the Ravenna Road  
15 Bridge over Tinker's Creek Improvement Project (SUM-CR 12-1.40), in Council District 1, in an  
16 amount not to exceed \$1,843,241.90, and appropriating funds in an amount not to exceed  
17 \$2,211,890.28; and

18  
19 WHEREAS, it is necessary to appropriate funds for Change Order No. 2 to the  
20 aforementioned construction contract, in an amount not to exceed \$24,971.98 (3.89% increase),  
21 including a local match of \$4,994.40 from Motor Vehicle and Gas Tax funds, for the period  
22 ending 12/31/15; and

23  
24 WHEREAS; the Ohio Department of Transportation provides 80% of the Project's costs  
25 and requires the local match of \$4,994.40, which will be paid from Motor Vehicle Gas Tax  
26 Funds; and

27  
28 WHEREAS, because Change Order Nos. 1 and 2 to the aforementioned construction  
29 contract do not cumulatively exceed 15%, pursuant to Section 177.14(e) of the Codified  
30 Ordinances, the approval of the Board of Control or County Council is not required; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that the appropriation of the aforementioned funds is necessary and in the best interest of the  
34 County of Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

20 effect and be in force at the earliest time provided by law.


