A Resolution authorizing the County Executive to execute a Memorandum of Understanding and subsequent Purchase Agreement, District Modification Agreement and other necessary documents with the Cities of Norton and Barberton to consolidate sanitary sewer facilities and service in the City of Norton, for the Executive, and declaring an emergency.

WHEREAS, the County is the owner of certain sanitary sewer facilities in the City of Norton ("Norton") which transmit sanitary sewer flow to the City of Barberton ("Barberton") sewer treatment plant for treatment; and

WHEREAS, Norton also owns certain sanitary sewer assets within Norton which also collects sanitary sewer flow for treatment in Barberton; and

WHEREAS, the County Executive has negotiated a Memorandum of Understanding ("MOU") with Norton and Barberton setting forth a potential transaction whereby the County would sell to Barberton, and Norton would transfer to Barberton, their respective sanitary sewer facilities; and

WHEREAS, pursuant to the MOU, Barberton would pay the County the sum of \$1,750,000.00; and

WHEREAS, pursuant to the MOU, Barberton would assume the customers currently served by the County and Barberton would become the exclusive sanitary sewer provider for Norton; and

WHEREAS, the County Executive has recommended to this Council that authorizing him to execute the MOU and subsequent Purchase Agreement, District Modification Agreement and other necessary documents, is beneficial financially to the County and promotes a regionalized solution to address pressing environmental issues in Norton; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive to execute the MOU and to further authorize the County Executive to execute a Purchase Agreement, District Modification Agreement and such other documents set forth in and/or necessary to fulfilling the MOU.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
