7 **An Ordinance amending Chapter 923 of the Codified Ordinances of the County of Summit,**
8 **entitled “Fees and User Charge System,” for the Executive’s Department of Environmental**
9 **Services, and declaring an emergency.**

11 WHEREAS, in Ordinance No. 2006-550, County Council amended certain sections of
12 Chapter 923 of the Codified Ordinances of the County of Summit, entitled “Fees and User
13 Charge System,” and set the various user charges, surcharges and fees for the Summit County
14 Metropolitan Sewer District, administered by the Executive’s Department of Environmental
15 Services; and

17 WHEREAS, Ordinance No. 2014-526 amended Chapter 923 to establish user charges,
18 surcharges and fees into the first quarter of 2015; and

19
20 WHEREAS, it is necessary to set all user charges, surcharges and fees in Chapter 923 for
21 the remainder of year 2015 and beyond; and

22
23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the flat rate user charge should be reduced by ten percent for the remainder of year 2015 and
25 beyond, and all other user charges, surcharges and fees contained in Chapter 923 of the Codified
26 Ordinances of the County of Summit should remain unchanged for the remainder of the year
27 2015 and beyond, until further action is taken by this Council; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary to amend Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08
31 of the Codified Ordinances of the County of Summit to implement said extension of the user
32 charges, surcharges and fees;

34 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
35 of Ohio, that:

39 Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified
40 Ordinances of the County of Summit are hereby amended as shown on Exhibit A, attached
41 hereto and incorporated herein as if fully restated.

45 This Ordinance is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit, and for the further reason of immediately
47 amending Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified
48 Ordinances of the County of Summit, in order to immediately implement the user charges,
49 surcharges and fees for the Summit County Metropolitan Sewer District for the remainder of
50 year 2015.

SECTION 3




