7 **A Resolution authorizing the County Executive to execute a three-year policing contract**
8 **with Coventry Township, for the period from 1/1/15 through 12/31/17, for a total amount of**
9 **\$2,222,524.10 during the three-year term of the contract, for the Sheriff, and declaring an**
10 **emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2011-495, which
13 authorized the County Executive to execute a three-year policing contract with Coventry
14 Township in Council District 8, which expired on 12/31/14; and

15
16 WHEREAS, Coventry Township has requested that the County of Summit enter into a
17 new three-year contract, for the period from 1/1/15 through 12/31/17, pursuant to which the
18 Sheriff will provide 9,960.00 deputy/sergeant hours and 624 Direct Indictment hours, , and

20 WHEREAS, Coventry Township has agreed to pay the County \$725,451.52 for the first
21 year, \$740,983.60 for the second year and \$756,088.98 for the third year, for a total amount of
22 \$2,222,524.10 during the three-year term of the contract; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute for aforementioned policing contract with Coventry Township;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

31 SECTION 1

33 The County Executive is hereby authorized to execute a three-year policing contract with
34 Coventry Township, for the period from 1/1/15 through 12/31/17, pursuant to which the County
35 Sheriff will provide Coventry Township with 9,960.00 deputy/sergeant hours and 624 direct
36 indictment hours in exchange for payment by Coventry Township in the amount of \$725,451.52
37 for the first year, \$740,983.60 for the second year and \$756,088.98 for the third year, for a total
38 amount of \$2,222,524.10 during the three-year term of the contract.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit and for the further purpose of immediately
44 providing necessary policing for Coventry Township, in Council District 8, effective 1/1/15.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
