7 **A Resolution authorizing the County Engineer to advertise for bids for the purchase of**  
8 **miscellaneous road and ditch maintenance materials, for an estimated total cost not to**  
9 **exceed \$267,200.00 for the Engineer, and declaring an emergency.**

10  
11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
12 requires this Council's authorization for the County Engineer to advertise for bids; and

13  
14 WHEREAS, the Engineer needs miscellaneous road and ditch maintenance materials for  
15 operations during calendar year 2015; and

16  
17 WHEREAS, in calendar year 2014, the Engineer allocated approximately \$80,000.00 for  
18 bituminous materials, approximately \$146,200.00 for limestone materials, approximately  
19 \$75,000.00 for clay fill materials and approximately \$15,000.00 for pipe materials purchased  
20 from vendors selected under Resolution No. 2014-224; and

21  
22 WHEREAS, the Engineer anticipates the quantities of limestone, clay fill, bituminous  
23 and pipe materials used during calendar year 2015 to be approximately the same as were used  
24 during calendar year 2014, with the price of such materials adjusted to the bid prices obtained  
25 through the requested advertisement, and with all significant expenditures requiring separate  
26 Board of Control approval; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Engineer to  
30 advertise for bids for the aforementioned materials;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for the following materials, for  
38 use by the Engineer, with an estimated total cost not to exceed \$267,200.00:

40 **Limestone Materials:** No. 1, No. 2, No. 4, No. 8, No. 57/67, No. 304, No. 601 A, B, C, D,  
41 Armor, No. 9, No. 9 Washed and Clay Fill Material

42  
43 **Bituminous Materials:** SS 921/ 405 Cold Mix, No. 301 Hot Mix, No. 404/448 Hot Mix and  
44 HFRS-2 Emulsion.

46 **Culvert Pipe Materials:** 12", 15", 18", 24", and 36".

4 SECTION 2

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
7 welfare of the citizens of the County of Summit, and for the further reason that it will  
8 immediately provide the Engineer with necessary materials for the maintenance of County  
9 roadways.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,  
22 were in meetings open to the public, in compliance with all legal requirements, including Section  
23 121.22 of the Ohio Revised Code.
