7 **A Resolution authorizing the County Executive to establish the intersection of Riverview**
8 **Road and Boston Mills Road in Boston Township as a four-way stop intersection for the**
9 **period 5/11/15 through 5/26/15, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Section 5553.02 of the Ohio Revised Code grants authority to locate,
12 alter, or vacate roads to the Board of County Commissioners; and

13
14 WHEREAS, Section 5553.04 of the Ohio Revised Code establishes the procedure for
15 establishing, altering or vacating roads; and

16
17 WHEREAS, the Cuyahoga Valley Scenic Railroad desires to celebrate the “Day Out
18 With Thomas” event, and has asked the Engineer to assist in traffic control by establishing a
19 four-way stop at the intersection at Riverview Road and Boston Mills Road, in Council District
20 1, due to the increased vehicular and pedestrian traffic anticipated during the time of this event;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that establishing the aforementioned temporary four-way stop intersection is necessary and in the
24 best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

29 SECTION 1

31 The County Executive is hereby authorized to establish the intersection of Riverview
32 Road and Boston Mills Road a temporary four-way stop intersection for the period 5/11/15
33 through 5/26/15 after which said intersection shall revert to a two-way stop intersection with the
34 stop signs installed for the eastbound and westbound Boston Mills Road traffic.

36 SECTION 2

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason that it ensures safe
40 travel for pedestrians and workers for the “Day Out With Thomas” event.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
