11 WHEREAS, the Board of Control, at its meeting held March 18, 2015, awarded a
12 purchase order with Montrose Ford for twelve Ford vehicles per attached Exhibit A, under CUE
13 pricing, subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a purchase order with Montrose Ford for twelve
24 Ford vehicles per attached Exhibit A, under CUE pricing, in a total amount not to exceed
25 \$301,259.23, is hereby confirmed and the County Executive is hereby authorized to execute such
26 purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 replace fleet vehicles in 2015.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.
