7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of a 2015 Summer**
9 **Youth Employment Program grant, for the period 5/1/15 through 10/31/15, in the amount**
10 **of \$1,558,301.00, with no local cash match requirement, and appropriating grant funds, for**
11 **the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the County Executive's Department of Job and Family Services ("SCJFS")
14 has received an award of federal funds from the Ohio Department of Job and Family Services
15 ("ODJFS") for a 2015 Summer Youth Employment Program grant of Temporary Assistance for
16 Needy Families ("TANF") funds, in the amount of \$1,558,301.00, with no local cash match
17 requirement; and

19 WHEREAS, this TANF funding will support the 2015 Summer Youth Employment
20 Program which will operate from 5/1/15 through 10/31/15; and

21
22 WHEREAS, the 2015 Summer Youth Employment Program will provide low income
23 TANF-eligible youths the opportunity to gain valuable work experience while earning a
24 paycheck; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 immediately execute any documents necessary to accept the award of the aforementioned grant
29 from ODJFS, and to appropriate these grant funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award of a 2015 Summer Youth Employment Program grant from the Ohio Department of
38 Job and Family Services ("ODJFS"), for the period 5/1/15 through 10/31/15, in the amount of
39 \$1,558,301.00, with no local cash match requirement.
