7 **A Resolution appropriating funds in the amount of \$36,489.23 in the Medical Examiner's**
8 **Lab Fund, for the fiscal year ending 12/31/15, for the Medical Examiner, and declaring an**
9 **emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2014-515, which approved
12 and appropriated the 2015 operating budget for the Medical Examiner – Lab Fund for the fiscal
13 year ending 12/31/15; and

15 WHEREAS, the Medical Examiner plans to hire a Forensic Investigator, a full-time,
16 bargaining unit position, in order to fill a current vacancy and help meet the demands of the
17 increase in cases; and

18
19 WHEREAS, it is necessary to increase the operating budget by \$22,296.40 in the current
20 personal services-payroll appropriation in order to provide adequate funding; and

21
22 WHEREAS, it is necessary to increase the operating budget by \$14,192.83 in the current
23 employee benefits appropriation in order to provide adequate funding; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned increase of the appropriations is necessary and in the best interest of the
27 County of Summit;
