7 **A Resolution confirming an award by the Board of Control of Change Order No. 2 to a**  
8 **construction contract with Lake County Sewer Company, Inc., for grouting of laterals for**  
9 **the WWTP 32 Sanitary Sewer Rehabilitation Project, in an amount not to exceed**  
10 **\$27,900.00 (28% accumulative increase), for the Executive's Department of Environmental**  
11 **Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 1, 2015, awarded Change  
14 Order No. 2 to a construction contract with Lake County Sewer Company, Inc., for grouting of  
15 62 laterals for the WWTP 32 Sanitary Sewer Rehabilitation Project Q-833, in Council District 7,  
16 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, by reviewing all pertinent information,  
19 that the change order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of Change Order No. 2 to a construction contract with  
27 Lake County Sewer Company, Inc., for grouting of 62 laterals for the WWTP 32 Sanitary Sewer  
28 Rehabilitation Project Q-833, in Council District 7, in an amount not to exceed \$27,900.00 (28%  
29 accumulative increase), is hereby confirmed and the County Executive is hereby authorized to  
30 execute such change order.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for the grouting of 62 additional laterals for Project Q-833 in Council District 7.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.
