7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services and Ohio Department of Medicaid for grants**
9 **received by the County Executive's Department of Job and Family Services during State**
10 **Fiscal Years 2016-2017 (7/1/15 through 6/30/17), for the Executive's Department of Job and**
11 **Family Services, and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
14 that the Ohio Department of Job and Family Services may only make grants to counties through
15 subgrant agreements described in that Section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
18 Department of Job and Family Services developed a standard subgrant agreement to be executed
19 by the Executive or commissioners of each county prior to receiving Department of Job and
20 Family Services grant funds; and

22 WHEREAS, effective with the term of the proposed subgrant agreement, the state has
23 determined it necessary to add the Ohio Department of Medicaid to the agreement due to the
24 County's receipt of funds from that agency; and

26 WHEREAS, the County Department of Job and Family Services has received from the
27 State the standard subgrant agreement for State Fiscal Years ("SFY") 2016-2017 (7/1/15 through
28 6/30/17) that sets forth the rights and responsibilities of the Ohio Department of Job and Family
29 Services, the Ohio Department of Medicaid and the County Department of Job and Family
30 Services in relation to any grant that is awarded for SFY 2016-2017; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
34 execute said subgrant agreement for SFY 2016-2017;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that;

41 The County Executive is authorized to execute a subgrant agreement with the Ohio
42 Department of Job and Family Services and Ohio Department of Medicaid for grants received by
43 the County Department of Job and Family Services for State Fiscal Years 2016-2017 (7/1/15
44 through 6/30/17). A copy of said subgrant agreement is attached to this Resolution as Exhibit A
45 and incorporated herein as if fully restated.

9 and Family Services is eligible to awarded grant funds from the Ohio Department of Job and
10 Family Services and Ohio Department of Medicaid for SFY 2016-2017.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.
