7 **A Resolution confirming an award by the Board of Control of a purchase contract renewal**
8 **(first of two) with SmartBill Ltd. for the preparation and mailing of real estate tax bills and**
9 **dog licenses, for the period 5/1/15 through 4/30/17, in an amount not to exceed \$467,257.20,**
10 **for the Fiscal Officer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 8, 2015, awarded a purchase
13 contract renewal (first of two) with SmartBill Ltd. for the preparation and mailing of real estate
14 tax bills and dog licenses, for the period 5/1/15 through 4/30/17, subject to confirmation by
15 County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the purchase contract renewal is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase contract renewal (first of two) with
26 SmartBill Ltd. for the preparation and mailing of real estate tax bills and dog licenses, for the
27 period 5/1/15 through 4/30/17, in an amount not to exceed \$467,257.20, is hereby confirmed and
28 the County Executive is hereby authorized to execute such purchase contract renewal.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for the preparation and mailing of real estate tax bills and dog licenses effective 5/1/15.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
