7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, authorizing purchases by the Court of Common Pleas General Division from**
9 **SoundCom, as Best Practical Source, for courtroom technology and maintenance services,**
10 **in a total aggregate amount not to exceed \$50,000.00, in calendar year 2015, for the Court**
11 **of Common Pleas General Division, and declaring an emergency.**

12
13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
14 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon
16 authorization of County Council; and

17
18 WHEREAS, the Executive's Department of Finance and Budget and the Board of
19 Control have previously approved purchases by the Court of Common Pleas General Division
20 from SoundCom, as Best Practical Source, for courtroom technology and maintenance services
21 for five technology courtrooms, in the aggregate amount of \$176.00, in calendar year 2015; and

23 WHEREAS, the Court of Common Pleas General Division anticipates additional
24 purchases from SoundCom, as Best Practical Source, for courtroom technology and maintenance
25 services for five technology courtrooms, in an additional amount not to exceed \$49,824.00, for a
26 total aggregate amount not to exceed \$50,000.00, in calendar year 2015; and

28 WHEREAS this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize purchases by the
30 Court of Common Pleas General Division from SoundCom, as Best Practical Source, for
31 courtroom technology and maintenance services, in a total aggregate amount not to exceed
32 \$50,000.00, in calendar year 2015;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 This Council hereby authorizes purchases by the Court of Common Pleas General
40 Division from SoundCom, as Best Practical Source, for courtroom technology and maintenance
41 services for five technology courtrooms, in a total aggregate amount not to exceed \$50,000.00, in
42 calendar year 2015.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit, and for the further reason to immediately
48 provide necessary courtroom technology and maintenance services to the Court of Common
49 Pleas General Division in calendar year 2015.
