7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **East Manufacturing Corporation for one aluminum dump trailer, in an amount not to**
9 **exceed \$59,539.00, for the Executive's Department of Environmental Services, and**
10 **declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 15, 2015, awarded a purchase
13 contract with East Manufacturing Corporation for one 28-foot by 96-inch aluminum dump trailer
14 with cab controls, suspension controls, air bag springs and a tarp system, to haul wastewater
15 sludge from multiple wastewater treatment plants, subject to confirmation by County Council;

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a purchase contract with East Manufacturing
27 Corporation for one 28-foot by 96-inch aluminum dump trailer with cab controls, suspension
28 controls, air bag springs and a tarp system, to haul wastewater sludge from multiple wastewater
29 treatment plants, in an amount not to exceed \$59,539.00, is hereby confirmed and the County
30 Executive is hereby authorized to execute such contract.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately meet
36 requirements of the Ohio Environmental Protection Agency and to maintain wastewater
37 treatment services.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.






