7 **A Resolution authorizing the County Executive to advertise for bids for the Fishcreek Roof**
8 **Replacement Project, for an estimated total cost not to exceed \$213,800.00, for the**
9 **Executive's Department of Environmental Services, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

14 WHEREAS, the County Executive wishes to advertise for bids for the Fishcreek Roof
15 Replacement Project to replace the roofs on the Administration Building and the Filter Building,
16 in Council District 3, for an estimated total cost not to exceed \$213,800.00; and

18 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
22 advertise for bids for the Fishcreek Roof Replacement Project, in Council District 3;

29 The County Executive is authorized to advertise for bids for the Fishcreek Roof
30 Replacement Project to replace the roofs on the Administration Building and the Filter Building,
31 in Council District 3, for an estimated total cost not to exceed \$213,800.00.

35 This Resolution is declared an emergency in the interest of the health, safety, and welfare
36 of the citizens of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids for the Fishcreek Roof Replacement Project in

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
