A Resolution authorizing the County Executive to execute the First Extension and Amendment of a lease with New Plaza Management, LLC, as Best Practical Source, subject to the approval of the Board of Control, for space for a Title Bureau Office, for a five-year term, from 7/1/15 through 6/30/20, for a total amount not to exceed \$75,950.00, for the Clerk of Courts, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2008-047, which authorized the County Executive to execute a lease, subject to the approval of the Board of Control, with New Plaza Management, LLC, for 1,960 square feet of space located at Northfield Plaza 10333 Northfield Road, Northfield, Ohio 44067, in Council District 1, for use as a Title Bureau Office by the Clerk of Courts, for a seven-year term, for the amount of \$5.00 per square foot for rent, plus a common area charge of \$1.20 per square foot for the first two years of the lease, to be increased by an amount not to exceed 8% every two years, plus \$595.24 per month to repay build-out costs of \$50,000.16 to be advanced by New Plaza Management, LLC, for an amount not to exceed \$136,847.76 over the seven-year term of the lease (the "Lease"); and

WHEREAS, the County wishes to enter into the First Extension and Amendment of a lease with New Plaza Management, LLC, as Best Practical Source, for 1,960 square feet of office space located at 10333 Northfield Road, Northfield, Ohio 44067, in Council District 1, for use as a Title Bureau Office for the Clerk of Courts, for a five-year term, from 7/1/15 through 6/30/20, for rent in an amount not to exceed \$6.00 per square foot or \$980.00 per month, or total amount not to exceed \$11,760.00 annually, and a Common Area Charge not to exceed \$1.75 per square foot or \$285.83 per month, with one monthly payment in an amount not to exceed \$285.87, or a total amount of \$3,430.00 annually, for a total payment amount not to exceed \$15,190.00 annually, for a total amount not to exceed \$75,950.00 during the five-year Extended Term of the Lease; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the First Extension and Amendment of the Lease with New Plaza Management, LLC, subject to the approval of the Board of Control;

The County Executive is hereby authorized to execute First Extension and Amendment of a lease with New Plaza Management, LLC, as Best Practical Source, for 1,960 square feet of office space located at 10333 Northfield Road, Northfield, Ohio 44067, in Council District 1, for use as a Title Bureau Office for the Clerk of Courts, for a five-year term, from 7/1/15 through 6/30/20, for rent in an amount not to exceed \$6.00 per square foot or \$980.00 per month, or total amount of \$11,760.00 annually, and a Common Area Charge not to exceed \$1.75 per square foot or \$285.83 per month, with one monthly payment in an amount not to exceed \$285.87, or a total amount of \$3,430.00 annually, for a total payment amount not to exceed \$15,190.00 annually, for a total amount not to exceed \$75,950.00 during the five-year Extended Term of the Lease.
