7 **A Resolution confirming an award by the Board of Control of professional service**  
8 **contracts with certain providers for Workforce Innovation and Opportunity Act youth**  
9 **agreements, for the period 7/1/15 through 6/30/16, with two options to renew for a one-year**  
10 **period, in a total amount not to exceed \$625,000.00 for the first year, for the Executive's**  
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 6, 2015, awarded professional  
14 service contracts with certain providers for Workforce Innovation and Opportunity Act  
15 ("WIOA") youth agreements, for the period 7/1/15 through 6/30/16, with two options to renew  
16 for a one-year period, subject to confirmation by County Council; and

18 WHEREAS, the WIOA agreements provide for out-of-school and in-and-out-of-school  
19 youth employment and educational services; and

21 WHEREAS, a list of the providers is attached as Exhibit A; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the contracts are necessary and in the best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

31 The award by the Board of Control of contracts with certain providers per attached  
32 Exhibit A for Workforce Innovation and Opportunity Act ("WIOA") youth agreements, for the  
33 period 7/1/15 through 6/30/16, with two options to renew for a one-year period, in a total amount  
34 not to exceed \$625,000.00 for the first year, is hereby confirmed and the County Executive is  
35 hereby authorized to execute such contracts.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide for out-of-school and in-and-out-of-school youth employment and educational services  
42 effective 7/1/15.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
