7 **A Resolution authorizing the County Executive to execute a professional service contract**
8 **with ABM Parking Services, Inc., dba ABM Parking Services, subject to the approval of**
9 **the Board of Control, for operation and management of the Summit County Parking Deck,**
10 **for a 60-month term, from 8/1/15 through 7/31/20, in an amount not to exceed \$321,300.00,**
11 **for the Executive's Department of Administrative Services – Division of Physical Plants,**
12 **and declaring an emergency.**

14 WHEREAS, on May 1, 2015, the County of Summit issued a request for proposals for a
15 professional service contract for operation and management of the Summit County Parking Deck
16 located at 200 South High Street, Akron, Ohio 44308, in Council District 4, for a 60-month term,
17 from 8/1/15 through 7/31/20; and

19 WHEREAS, out of the five vendors to which the request for proposals was sent, the
20 County received one response, from ABM Parking Services, Inc., dba ABM Parking Services;

23 WHEREAS, the County of Summit wishes to enter into a professional service contract
24 with ABM Parking Services, Inc., dba ABM Parking Services, subject to the approval of the
25 Board of Control, for operation and management of the Summit County Parking Deck, located at
26 200 South High Street, Akron, Ohio 44308, in Council District 4, for a 60-month term, from
27 8/1/15 through 7/31/20, in an amount not to exceed \$5,355.00 per month, for a total amount not
28 to exceed \$321,300.00 over the 60-month term of the agreement; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County of Summit to authorize the County
32 Executive to execute the aforementioned professional service contract with ABM Parking
33 Services, Inc., dba ABM Parking Services, subject to the approval of the Board of Control;

44 8/1/15 through 7/31/20, in an amount not to exceed \$5,355.00 per month, for a total amount not
45 to exceed \$321,300.00 over the 60-month term of the agreement.




