

Crossroads youth with co-occurring substance abuse/dependence and mental health diagnosis may receive integrated co-occurring treatment (ICT) services. The advantage of this treatment modality is that one counselor works with the youth and family on both the substance abuse/dependence and the mental health disorder. The services are delivered in the community, i.e., home and school, and involve individual sessions with the youth and family sessions. The counselor provides case management services throughout the duration of the program, usually 3 to 6 months. Aftercare is provided, as appropriate for the individual youth and family by numerous community providers as determined by the youth's family, ICT counselor and Court.
