8 **contract with the Battered Women's Shelter of Summit and Medina Counties for**
9 **additional family stability case management and state-mandated domestic violence**
10 **services, for the period 10/1/15 through 9/30/16, in an amount not to exceed \$200,000.00,**
11 **for the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 15, 2015, awarded a
14 professional service contract with the Battered Women's Shelter of Summit and Medina
15 Counties for additional family stability case management and state-mandated domestic violence
16 services, for the period 10/1/15 through 9/30/16, in an amount not to exceed \$200,000.00,
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
20 that the aforementioned professional service contract is necessary and in the best interest of the
21 County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a professional service contract with the Battered
29 Women's Shelter of Summit and Medina Counties for additional family stability case
30 management and state-mandated domestic violence services, for the period 10/1/15 through
31 9/30/16, in an amount not to exceed \$200,000.00, is hereby confirmed and the County Executive
32 is hereby authorized to execute such professional service contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide additional family stability case management and state-mandated domestic violence
39 services effective 10/1/15.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
