7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the Court of Common Pleas - Juvenile Division to provide youth and**
9 **family strengthening program services which operates through a family resource center**
10 **model located at the Court, for the period 10/1/15 through 9/30/16, in an amount not to**
11 **exceed \$400,000.00, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held July 15, 2015, awarded an
15 intergovernmental agreement with the Court of Common Pleas - Juvenile Division to provide
16 youth and family strengthening program services which operates through a family resource
17 center model located at the Court, for the period 10/1/15 through 9/30/16, in an amount not to
18 exceed \$400,000.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned intergovernmental agreement is necessary and in the best interest of the
22 County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The award by the Board of Control of an intergovernmental agreement with the Court of
30 Common Pleas - Juvenile Division to provide youth and family strengthening program services
31 which operates through a family resource center model located at the Court, for the period
32 10/1/15 through 9/30/16, in an amount not to exceed \$400,000.00, is hereby confirmed and the
33 County Executive is hereby authorized to execute such intergovernmental agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 provide for the aforementioned program services through a family resource center model
40 effective 10/1/15.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
