7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**  
8 **professional service contract with Official Payments, as Best Practical Source, to allow the**  
9 **acceptance of credit card payments at the County Sheriff's Office for Carrying a**  
10 **Concealed Weapon background checks and record copy charges for a fee of \$1.95 per**  
11 **transaction to be charged to the customer, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2014-326, which  
14 confirmed an award by the Board of Control of a professional service contract with Official  
15 Payments, as Best Practical Source, for merchant services and bank card processing services for  
16 the Fiscal Office, Animal Control, Building Standards and Public Health, for a five-year term;

19 WHEREAS, the Board of Control, at its meeting held July 29, 2015, awarded Change  
20 Order No. 1 to said professional service contract with Official Payments, as Best Practical  
21 Source, to allow the acceptance of credit card payments at the County Sheriff's Office for  
22 Carrying a Concealed Weapon background checks and record copy charges for a fee of \$1.95 per  
23 transaction to be charged to the customer; and

25 WHEREAS, as is the case with the existing services under said professional service  
26 contract, there will be no fees charged to the County; and

28 WHEREAS, County Council has determined by reviewing all pertinent information that  
29 the aforementioned change order to the professional service contract with Official Payments is  
30 necessary and in the best interest of the County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The award by the Board of Control of Change Order No. 1 to a professional service  
38 contract with Official Payments, as Best Practical Source, to allow the acceptance of credit card  
39 payments at the County Sheriff's Office for Carrying a Concealed Weapon ("CCW")  
40 background checks and record copy charges for a fee of \$1.95 per transaction to be charged to  
41 the customer and the County Executive is hereby authorized to execute such change order.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and  
46 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
47 allowing the acceptance of credit card payments at the Sheriff's Office for CCW background  
48 checks and record copy charges.
