7 **A Resolution confirming an award by the Board of Control of a purchase order with**  
8 **Montrose Ford for a 2016 350 Ford Transit Van, LR, 15 Passenger Wagon, under**  
9 **Community University Education Purchasing Association pricing, for transporting inmates**  
10 **at the Summit County Jail, in an amount not to exceed \$31,892.28, for the Sheriff, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 29, 2015, awarded a purchase  
14 order with Montrose Ford for a 2016 350 Ford Transit Van, LR, 15 Passenger Wagon, under  
15 Community University Education Purchasing Association pricing, for transporting inmates at the  
16 Summit County Jail, in an amount not to exceed \$31,892.28, subject to confirmation by County  
17 Council; and

19 WHEREAS, County Council has determined by reviewing all pertinent information that  
20 the aforementioned purchase order with Montrose Ford is necessary and in the best interest of  
21 the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

26 SECTION 1

28 The award by the Board of Control of a purchase order with Montrose Ford for a 2016  
29 350 Ford Transit Van, LR, 15 Passenger Wagon, under Community University Education  
30 Purchasing Association pricing, for transporting inmates at the Summit County Jail, in an  
31 amount not to exceed \$31,892.28, is hereby confirmed and the County Executive is hereby  
32 authorized to execute such purchase order and any other documents necessary for said purchase.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
38 obtaining a necessary vehicle for the County Sheriff's Office to transport inmates.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating  
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and of any of its committees that resulted in such formal action,  
51 were in meetings open to the public, in compliance with all legal requirements, including Section  
52 121.22 of the Ohio Revised Code.
