12 and troopers to complete up to twenty-four hours of continuing professional training each
13 calendar year; and

15 WHEREAS, Section 109.802 of the Ohio Revised Code provides for a formula
16 reimbursement of continued professional training costs through the Ohio Attorney General's
17 Office; and

19 WHEREAS, the Ohio Attorney General's Office has issued a payment to the County
20 Sheriff's Office, in the amount of \$34,240.00, as reimbursement for continued professional
21 training costs; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that it is
24 necessary and in the best interest of the County of Summit to appropriate the aforementioned
25 continued professional training reimbursement funds received from the Ohio Attorney General's
26 Office, in the amount of \$34,240.00;
