7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Fiscal Year 2016 and 2017 Probation Improvement and Incentive grant from the**
9 **Ohio Department of Rehabilitation and Correction for the purpose of assisting**
10 **probationers in reintegrating into the community, for the period of 7/1/15 through 6/30/17,**
11 **in the amount of \$169,903.00, with no local cash match requirement and appropriating**
12 **funds, for the Court of Common Pleas – Adult Probation Department, and declaring an**
13 **emergency.**

15 WHEREAS, the County of Summit Court of Common Pleas – Adult Probation
16 Department has been awarded a Fiscal Year 2016 and 2017 Probation Improvement and
17 Incentive grant from the Ohio Department of Rehabilitation and Correction for the purpose of
18 providing additional programming for probationers in order to assist their successful
19 reintegration into the community, for the period of 7/1/15 through 6/30/17, in the amount of
20 \$169,903.00, with no local cash match requirement; and

22 WHEREAS, it is necessary to authorize the County Executive to execute any documents
23 necessary to accept the aforementioned grant from Ohio Department of Rehabilitation and
24 Correction and to appropriate the grant funds; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the aforementioned grant from the Ohio Department
29 of Rehabilitation and Correction and to appropriate the aforementioned grant funds, in the
30 amount of \$169,903.00, with no local cash match requirement and to appropriate these funds;
