7 **A Resolution authorizing the County Executive to advertise for bids for 2015-2016 winter**  
8 **season plowing and salting of County parking lots, for an estimated total cost not to exceed**  
9 **\$35,000.00, for the Executive's Department of Administrative Services – Physical Plants,**  
10 **and declaring an emergency.**

11  
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for 2015-2016 winter  
16 season plowing and salting of County parking lots at several locations, including the Summit  
17 County Jail, the Juvenile Court/Detention, Ohio Means Jobs Summit County and Title Bureau on  
18 Tallmadge Ave., the Medical Examiner's Office and the Summit County Animal Control  
19 Facility, in Council Districts 2 and 4, for an estimated total cost not to exceed \$35,000.00; and

21 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 advertise for bids for 2015-2016 winter season plowing and salting of County parking lots at  
26 several locations, in Council Districts 2 and 4, for an estimated total cost not to exceed  
27 \$35,000.00;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that;

34 The County Executive is authorized to advertise for bids for 2015-2016 winter season  
35 plowing and salting of County parking lots at several locations, including the Summit County  
36 Jail, the Juvenile Court/Detention, Ohio Means Jobs Summit County and Title Bureau on  
37 Tallmadge Ave., the Medical Examiner's Office and the Summit County Animal Control  
38 Facility, in Council Districts 2 and 4, for an estimated total cost not to exceed \$35,000.00.

42 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
43 of the citizens of the County of Summit, and for the further reason that it authorizes the  
44 Executive to immediately advertise for bids for 2015-2016 winter season plowing and salting of  
45 County parking lots at several locations, in Council Districts 2 and 4, for an estimated total cost  
46 not to exceed \$35,000.00.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
52 effect and be in force at the earliest time provided by law.
