7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award from the County Executive’s Department of Job and Family Services of a**  
9 **Federal Fiscal Year 2016 Temporary Assistance to Needy Families grant to the Court of**  
10 **Common Pleas – Juvenile Division, for its Family Resource Center, for the period 10/1/15**  
11 **through 9/30/16, in the amount of \$400,000.00, with no local cash match requirement, and**  
12 **appropriating grant funds, for the County of Summit Court of Common Pleas – Juvenile**  
13 **Division, and declaring an emergency.**

14  
15 WHEREAS, the County Executive’s Department of Job and Family Services has  
16 awarded a Federal Fiscal Year 2016 Temporary Assistance to Needy Families (“TANF”) grant to  
17 the Court of Common Pleas – Juvenile Division for its Family Resource Center, for the period  
18 10/1/15 through 9/30/16, in the amount of \$400,000.00, with no local cash match requirement;

21 WHEREAS, the Family Resource Center, which was established in 2006 through a grant  
22 from DJFS, provides case management to at risk youth and their families who are involved in  
23 domestic violence disputes, are pregnant or parenting teens, are teens at risk of dropping out of  
24 school or are returning from long term stays at the Ohio Department of Youth Services, detention  
25 or other placements; and

27 WHEREAS, this Council previously adopted Resolution No. 2015-327, which confirmed  
28 an award by the Board of Control an intergovernmental agreement with the Juvenile Division to  
29 provide youth and family strengthening program services which operates through a family  
30 resource center model located at the Court, for the period 10/1/15 through 9/30/16, in an amount  
31 not to exceed \$400,000.00; and

33 WHEREAS, it is necessary to appropriate the TANF grant funds; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
36 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
37 execute any documents necessary to accept the award of the aforementioned Federal Fiscal Year  
38 2016 TANF grant from DJFS and to appropriate said grant funds;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
41 of Ohio, that:

45 The County Executive is hereby authorized to execute any documents necessary to accept

48 Resource Center, for the period 10/1/15 through 9/30/16, in the amount of \$400,000.00, with no  
49 local cash match requirement.
