15 Council; and

18 that the purchase order with Graphic Enterprises Office Solutions, Inc. is necessary and in the
19 best interest of the County; and

28 on 9/15/15, in an amount not to exceed \$52,884.00, is hereby confirmed and the County
29 Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the aforementioned ecopy scan stations.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.


